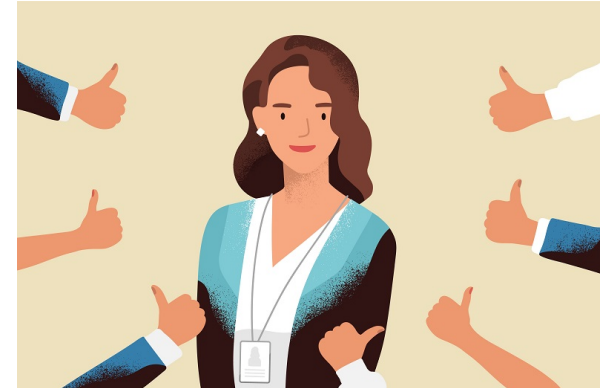
ACOTE Standards guiding Capstone Dissemination

ACOTE Standard D.1.8

Ensure completion and dissemination of an individual doctoral capstone project that relates to the doctoral capstone experience and demonstrates synthesis of in-depth knowledge in the focused area of study

Why do we disseminate?

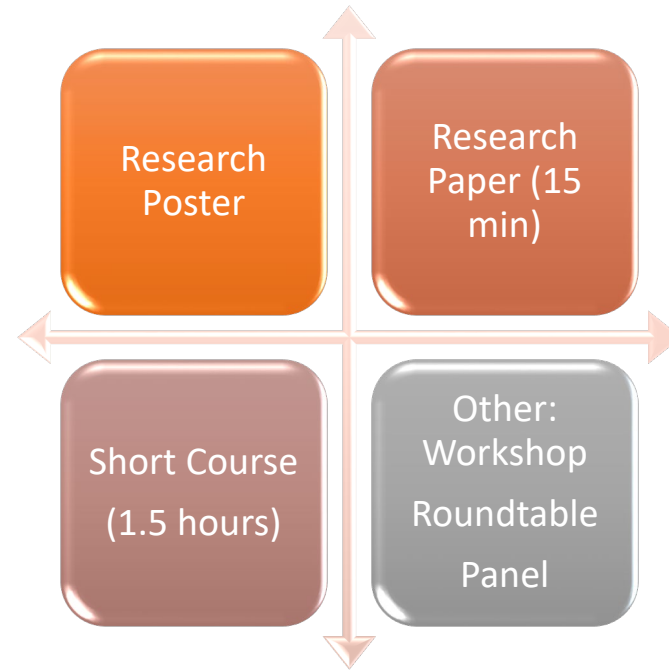
- Sharing knowledge
 - Can reach a broad range of stakeholders
 - Allows for duplication
- Personal recognition
- Recognition for faculty and/or community mentor(s)
 - Publications and presentations used as key “statistic” in academia

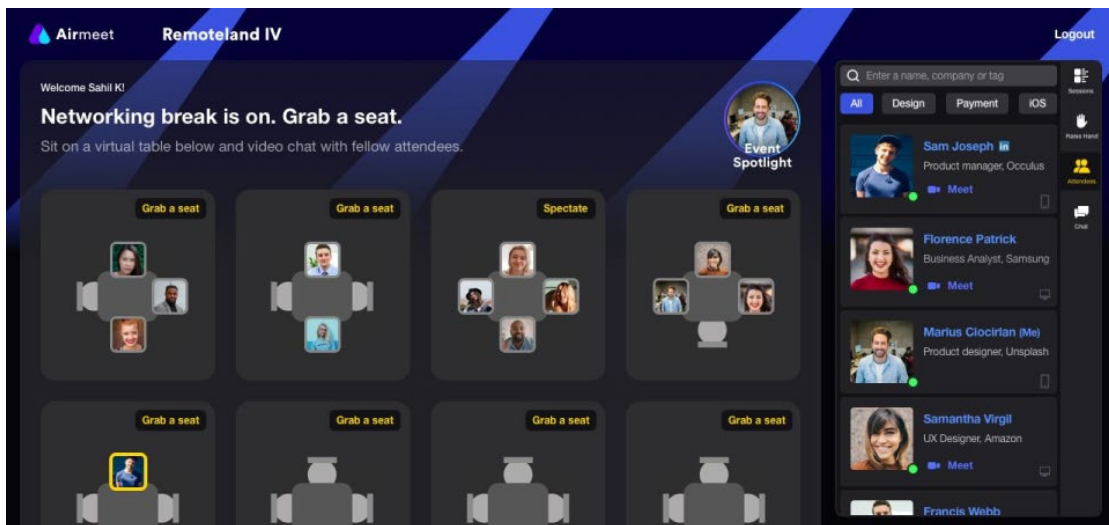


Options for Dissemination (2)

Things to consider before deciding to publish capstone work

- What is the **mission** or **scope** of the journal?
- **What types of articles** do they accept (e.g., original research, systematic reviews, case studies, brief reports, opinion pieces)
- Is there a **cost** associated with publishing?
 - **Open access**- free immediate access to, and unrestricted reuse of, original works of all types. Authors agree to make articles legally available for reuse, without permission or fees, for virtually any purpose. Anyone may copy, distribute or reuse these articles, as long as the author and original source are properly cited.
- What is the level of rigor expected for research publications?

Requirements for Rigor



- **Quantitative studies:** controlling for threats to internal/external validity, choosing appropriate designs, identifying testable hypotheses, having adequate sample sizes, considering statistical power.
- **Qualitative studies:** using reflexivity, reaching data saturation, establishing credibility, transferability, dependability and confirmability of findings.
- **Review Articles:** considerations for how databases were searched, articles were selected, and how information was synthesized (i.e., PRISMA checklist).

Other Requirements for Peer Review

- **Impact:** the work has to be novel with potential significance to the field
 - Single case studies HAVE to be in a novel area where there is not higher level of evidence
 - Review articles should cover topics that have not already been reviewed in the past 3-5 years (should add something NEW)
- Educational research has to go to appropriate outlet
- Assessment tools should be valid and reliable
 - Some journals may not accept studies that use self-developed questionnaires or surveys

Timeline for peer-review publication

- Preparation submission
- 30-50 days for peer-review
- Revision process
- 30-50 days for peer-review
- Can continue for multiple rounds of revision
- After acceptance, 6-8 months before production process completed and article published



Authorship



- Authors must have an **identifiable contribution**
- **Lead author:** assumes overall responsibility + insures integrity , serves as contact with editors, approves drafts, documents all files
- **Co-authors:** authored part of the manuscripts contents, contributions to the study may include:
 - Study design
 - Literature review
 - Statistical analyses
 - Data collection and preparation
 - Manuscript generation, editing, formatting
- **Author order-** best determined at the start of writing
 - Student s generally are 1st author on papers stemming from their thesis or dissertation
 - Last authors denotes “mentor”, “lab director”, or “PI on grant” (place of prestige)

Example: ICMJE Requirements for Authorship

The ICMJE recommends that authorship be based on the following 4 criteria:

- Substantial contributions to the conception or design of the work; or the acquisition, analysis, or interpretation of data for the work; AND
- Drafting the work or revising it critically for important intellectual content; AND
- Final approval of the version to be published; AND
- Agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.

Preparing a peer-review article for submission

- Format has to match journal requirements (e.g. APA, spacing, font, blinding)- students cannot hand in their capstone papers
- Submissions might requires additional materials
 - CONSORT and PRISMA checklist
 - Pre-submission checklist for authors
 - Protocol registration (e.g., clinicaltrials.gov)



Final Thoughts

- Dissemination plan should be part of the initial project planning
- Capstone mentors may need to teach students about dissemination and the options available to them
- If the plan is to submit for peer-review, capstone mentors may want to have students sign an authorship agreement before they graduate
- Mentors and students can reach out to editors for advice before targeting that journal

Authors, editorial board members, and readers reflect an international OT constituency.

OTJR: Occupation, Participation, and Health

- Peer-reviewed journal sponsored by the American Occupational Therapy Foundation (AOTF)
- Aims to “advance knowledge and science in occupational therapy and related fields...through the publication of scholarly literature and research”
- Topics for publication: occupation, participation and health; occupational therapy or occupational science
- Will not publish educational research and protocol only manuscripts
- Qualitative, Quantitative, or Mixed Methods
- APA formatting/references
- ~5,000 words for original research articles

American Journal of Occupational Therapy

- Official research journal of the American Occupational Therapy Association
- Emphasis on effectiveness and instrument development studies
- **Will not publish:** case studies (SSD's must have an n=3), descriptions of clinical programs, protocols without outcome data, intervention manuals
- Intervention studies must be registered with clinicaltrials.gov
- Types of articles
 - Research article (5,000 words)
 - Critical Reviews (5,000 words)
 - Brief Reports (3,000 words)
 - Issue Is (3,000 words)
- Requires CONSORT statement and PRISMA checklist
